



# RECOGNIZE A COLLEAGUE

## *Kansas Speech-Language-Hearing Association Awards*

- **Honors of the Association:**

Purpose: To recognize Members who have made distinguished contributions and service to the field and the Association. Contributions can be related to teaching and/or research and/ or service to the profession and active involvement in KSHA.

- **SLP and AUD of the Year:**

Purpose: To recognize Members who have demonstrated exceptional contributions in the delivery of clinical services.

- **Special Service Awards:**

Purpose: To recognize Individuals who have made a specific contribution to the Association or to the professions.

- **Life KSHA Members** - Purpose: To recognize members who become Life Members. Life membership is granted upon written application when a previous full member reaches 65 years of age providing the individual has been a full Member in good standing for at least fifteen consecutive years prior to this age or application.

- **Deadline for KSHA Awards: August 12**

## *American Speech-Language-Hearing Foundation (ASHF) Awards:*

- **Clinical Achievement Award - Louis M. DiCarlo**

Purpose: To recognize demonstrated contributions to the advancement of knowledge in clinical practice in the professions within the past three years. Examples:

- Achievement with a single client or group of clients.
- Program development.
- Achievement in a state or local organization or government agency activity.
- Clinical teaching, research or administration. From among the state winners, one will be chosen to receive the Louis M. DiCarlo Award for Outstanding Recent Clinical Achievement.

- **Frank R. Kleffner Award**

Purpose: To recognize outstanding contributions to clinical science and practice over a twenty year or longer period of time.

- **Rolland J. Van Hattum Award for Clinical Excellence**

Purpose: To recognize outstanding contributions to clinical excellence in a school setting.
